O R D E R 29/09/2022

- The petitioner Sri Alok Shankar Das has filed one RTI petition before the Chief Secretary cum Chairman State Level Selection Committee for appointment on compassionate ground, Dispur, Guwahati, Assam on 18.4.2022 seeking following information:
 - (i) Whether the case of the applicant for compassionate appointment has been considered by the State Level Committee for compassionate appointment, Govt. of Assam, for consideration as per order dated 8.2.2021 passed by the Hon'ble Gauhati High Court passed in WP(C) No.657/2021.
 - (ii) Please provide the copy of SLC minutes where my case is considered.
- The Staff Officer to Chief Secretary, Chief Secretary's Office, Dispur, Guwahati
 transferred the RTI application to the Principal Secretary to the Government of
 Assam, Home & Political Department, Dispur on 2.5.2022 with a direction to
 furnish the information to the petitioner directly.
- 3. Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority/ Chief Secretary cum Chairman State Level Selection Committee for appointment on compassionate ground, Dispur, Guwahati, Assam on 9.6.2022.
- 4. The Deputy Secretary to the Govt. of Assam, Home (A) Department sent a reply to the petitioner on 30.6.2022.
- 5. The petitioner then filed 2nd appeal before the Commission on 14.7.2022 and accordingly the matter was taken up for hearing.
- 6. The petitioner Sri Alok Shankar Das is absent.
- 7. The Public Authority is represented by Smti Rupa Phukan, SPIO & Deputy Secretary, Home Department.
- 8. The SPIO of Home (A) Department has submitted a written statement dated 27.9.2022 wherein it is mentioned that the sought for information has already been furnished to the petitioner on 23.9.2022.
- 9. Since the information is given, the case is disposed off.
