O R D E R 30/09/2022

- The petitioner Sri Harinarayan Pathak has filed one RTI petition before the Additional Deputy Commissioner & SPIO, O/o the Deputy Commissioner, Kamrup (M), Guwahati on 3.11.2021 seeking following information:
 - (1) Copy of the Registered deed of partnership no.354 Dated 30.1.2008 (with coloured photographs of the person s if available in the computer), Registered in the O/o the Sr. Sub-Registrar, Kamrup (M), District, Guwahati.
- Reportedly on not getting any information, the petitioner filed 1st appeal before the 1st Appellate Authority, O/o the Deputy Commissioner, Kamrup (M), Guwahati on 3.12.2021.
- 3. The Senior Sub-Registrar, Kamrup (M), Guwahati sent a letter to the petitioner on 13.12.2021 wherein it is mentioned that the information sought for has been verified in the available office records maintained regarding registered deeds and as per the record the Deed No. 354/2008 is not a partnership deed, hence the sought for information cannot be provided.
- 4. The petitioner then filed 2nd appeal before the Commission on 3.8.2022 and accordingly the matter was taken up for hearing.
- 5. The petitioner Sri Harinarayan Pathak though signed in the attendance sheet, did not remain available at the time of the hearing.
- 6. The Deemed PIO Sri Nirhandra Thaosen, PIO, Sr. Sub Registrar, Kamrup Metro though signed in the attendance sheet, but did not appear at the hearing.
- 7. The Sr. Sub Registrar has submitted a written statement dated 29.9.2022 which is taken into records.
- 8. This type of absence is an unbecoming for a government servant on the part of Sr. Sub Registrar.
- 9. <u>The Commission decides to hear the matter again and the Sr. Sub Registrar is</u> <u>directed to file an affidavit for his absence at the hearing after signing in the</u> <u>attendance sheet.</u>
- 10. Fix 28.10.2022 at 11:30 AM as the next date of hearing.
