**O R D E R**  
**30/09/2022**

1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO, O/o the Chief Engineer, Public Health Engineer Department, Assam, Hengrabari, Guwahati 36 on 31.5.2022 seeking following information:  
(1) Please furnish in details of the year wise statement of procurement which was procured by the PHE (WSSO) viz. name of the scheme, tender number and date, sanction number and date, item, price, numbers of items procured and distributed, name of the supplier, fund involved and released during the period 2016-17 to till date.
2. The SPIO, O/o the Chief Engineer (PHE), Water, Assam, Hengrabari, Guwahati 36 forwarded the RTI petition to the SPIO, O/o the Deputy Director of Key Resource Center (KRC), JJM, Betkuchi, Guwahati on 10.6.2022.
3. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> Appeal before the First Appellate Authority/ Chief Engineer, PHE Department, Assam, Hengrabari, Guwahati on 4.7.2022.  
The First Appellate Authority sent a letter to the petitioner on 5.8.2022 stating the petitioner to come and inspect the documents during office hours at their office.  
The petitioner then filed 2<sup>nd</sup> appeal before the Commission on 17.8.2022 and accordingly, the matter was taken up for hearing.
4. The petitioner Sri Joydeb Das is present.
5. The Public Authority is represented by Sri Tapan Sharma, SPIO, O/o the Chief Engineer (PHE), Hengrabari, Guwahati.
6. The petitioner said that he need only the statements not the detailed documents.
7. The SPIO Sri Tapan Sharma mentioned that the files are ready and it will take two days more to prepare the statements and request the presence of petitioner at their respective office.
8. Therefore, the Commission orders that the petitioner to remain present at the O/o the Chief Engineer (PHE), Water, Assam, Hengrabari, Guwahati at 11:00 AM on 1.10.2022 to collect the information relating to his RTI query.
9. The SPIO is directed to prepare comprehensive and appropriate statement relating to the replies of the RTI petition and hand over directly to the petitioner.

10. In view of the above, the case is conditionally disposed off.
