O R D E R 30/09/2022

- 1. In compliance to order dated 4.7.2022, Ms. Mitalee Lahkar, ACS, Registrar, Assam Information Commission has visited the office of Deemed PIO i.e., Branch Manager, Assam Seeds Corporation, Dibrugarh and Tinsukia Branch to enquire into the contention of the SPIO, i.e., information relating to bulky documents and submit a report thereof.
- 2. Ms. Mitalee Lahkar, ACS, Registrar, Assam Information Commission has submitted a report dated 26.9.2022 after conducting an enquiry from 13.9.2022 to 16.9.2022 wherein she has mentioned that the Authority concerned produced only 218 pages of Challans and Supply order, receipt/distribution etc during the course of enquiry and intimated that some of the documents are available with concerned ADOs and DO's of both the districts.

She relying on the submission of the SPIO has further mentioned that due to ongoing audit, some documents are also could not be produced as they are at the Head offices.

- In light of it, and in continuation of order dated 4.7.2022, <u>the Commission directs</u> <u>the SPIO i.e., i/c Branch Manager to furnish the copies of available documents at</u> <u>the office as well as the remaining documents available with the DO s and ADOs</u> <u>within seven days w.e.f., from today (i.e., within 7.10.2022) through Special</u> <u>Messenger as the case has been inordinately delayed.</u>
- 4. In view of the above the case is disposed off.
