<u>O R D E R</u> 10/10/2022

- 1. The petitioner Shri Joydeb Das has filed one RTI petition before the PIO, O/o the Additional Director, Welfare of Plain Tribes and Backward Classes, Kokrajhar, Assam on 13.7.2022 seeking following information:
 - (1) Please furnish copy of Administrative Approval for fixation of price, Financial Sanction, NIT, News Paper Advertisements, Comparative Statements, Quotation/Price with source of item submitted by the bidder and Minutes of the Price Bid which item was procured by the Additional Director WPT & BC during the period 2018-19 to 2019-20.
- Reportedly on not getting any information, the petitioner filed a complaint petition u/s 18(1) of the RTI Act,2005 before the Commission on 22.8.2022 and accordingly, the matter was taken up for hearing.
- 3. The petitioner Shri Joydeb Das is present.
- 4. The Public Authority is represented by Shri Rijendra Nath Brahma, Deputy Secretary, BTC and he is authorised by Smt. Pami Brahma, ACS, i/c Additional Director cum CHD, WPT & BC Deptt., B.T.C., Kokrajhar.
- 5. The i/c Additional Director cum CHD, WPT & BC Department, B.T.C, Kokrajhar has submitted a written statement dated 1.10.2022 which is taken into records.
- 6. The Deputy Secretary, BTC stated that he has brought the materials though he could not submit the information within thirty days, he has brought all the documents in connection with the RTI petition and he has submitted them to the petitioner.
- 7. <u>Had the information been furnished at least 2-3 days before the hearing, the petitioner could have gone through the documents furnished and come up for discussion</u>.
- 8. In light of the furnishing of the information, the case is conditionally disposed off. Authenticated copies to be given to all concerned.
