The petitioner Sri Shib Prasad Sarma is present.

Sri Pinak Pani Nath, Asstt. Statistical Officer and SPIO, Bongaigaon Zilla Parishad is also present and submitted one written statement bearing no. BNZPG-703/RTI/2022/342 dated 15.10.2022.

Seen the case record. The appellant submitted one application dated 16.11.2021 under the provision of RTI Act, 2005 before the SPIO, o/o the Bongaigaon Zilla Parishad seeking certain informations. He did not receive the desired information within the stipulated period of time and submitted 1<sup>st</sup> appeal dated 05.01.2022 before the CEO, Bongaigaon Zilla Parishad. He did not receive the desired information and submitted 2<sup>nd</sup> appeal dated 16.02.2022 before the Commission.
