O R D E R

07.09.2022

The appellant Sri Porosh Uddin is present.

The SPIO of Jamadarhat Dev. Block is absent without step.

Perused the case record. The appellant submitted one application under the provision of RTI Act, 2005 before the PIO of Zilla Parishad, Dhubri.

Seen the RTI application dated 24.01.2022. The applicant desires to have informations about the schemes executed under the 14th Finance Commission in Dingdingaparuwa Gaon Panchayat of Jamadarhat Dev. Block for the period from 2016-17, 2017-18, 2018-19 and 2019-20. He did not receive the desired informations within the stipulated period of time and from the records submitted along with the 2nd appeal petition, it is seen that the CEO and 1st appellate authority of Dhubri Zilla Parishad passed an order directing the SPIO of Jamadarhat Dev. Block to provide with the informations to the appellant within 28.04.2022 vide order bearing no. ZPD-52/Pt-XIII/RTI/2021-22/158 dated 19.04.2022. It is stated in the order that the Asstt. BDO and SPIO, Jamadarhat Dev. Block submitted one undertaking that the informations are ready and can be provided to the appellant. Still the SPIO had not furnished the desired informations for which the appellant preferred 2nd appeal dated 19.05.2022 before the Commission.

It is observed that the SPIO of Jamadarhat Dev. Block has denied the order of the CEO and 1st appellate authority of Dhubri Zilla Parishad by not furnishing the informations to the appellant. Therefore, he/she is directed to appear before the Commission on next date of hearing during proclamation of penalty.

Fix next date of hearing on 27.09.2022 at 12:00 Noon. This order shall constitute notice for hearing.
