O R D E R
20-05-2022

1. The appellant Shri Sanjib Tamuly is present.
2. The SPIO, O/o the BDO, Murkongselek Development Block, P.O. Murkongselek, Jonai, Distt. Dhemaji, is absent without any intimation. The hearing has been taken up despite the absence of the Public Authority because the appellant has travelled all the way from Dhemaji to attend the hearing today.
3. Records show that the appellant Shri Tamuly had submitted one RTI application to the SPIO, O/o the BDO, Murkongselek Development Block, on 06.10.2021 seeking certain informations under 8 queries. On not getting any response he submitted a 1st appeal on 08.11.2021. No record is available on whether the First Appellate Authority, O/o the BDO, Murkongselek Development Block, had disposed or not the 1st Appeal dated 08.11.2021, submitted by the appellant Shri Tamuly. On 13.01.2022, the appellant Shri Tamuly submitted a 2nd Appeal before this Commission along with which he submitted photocopy of a letter apparently written to him by one Shri Bablu Pegu dated 22.12.2021 in which it has been mentioned that informations related to queries No. 1-5 had been already provided, and that information against queries No 6,7 & 8 would be furnished soon. The said letter dated 22.12.2021 purportedly issued to the appellant Shri Tamuly from the O/o the BDO, Murkongselek Development Block, however is on plain paper and neither has any official reference number nor official seal and name and designation of the issuing authority. **The BDO, Murkongselek Development Block, is directed to enquire into whether the BDO's office had actually issued any such letter on plain paper to the appellant Shri Tamuly on 22.12.2021, and submit a report to the Commission on the authenticity of the same which has been submitted by the appellant as part of his 2nd Appeal. This report of the BDO shall reach the Commission within 15 (fifteen) days from the date of receipt of this order.**
4. **A copy of the letter dated 22.12.2021 purportedly issued by the BDO's office be also provided to the BDO.**
5. **The SPIO, O/o the BDO, Murkongselek Development Block, is directed to furnish the remaining informations as stated in the letter dated 22.12.2021 to**

the appellant Shri Tamuly within 10 (ten) days from the date of receipt of this order free of cost.

6. With the above order, this 2nd Appeal is hereby disposed of.
