<u>O R D E R</u> 19-05-2022

- 1. The appellant Md. Amir Hussain is absent without any intimation.
- 2. The SPIO, O/o the Food, Civil Supplies & Consumer Affairs, Darrang, Mangaldoi, is absent. But the Commission has received a letter dated 13.05.2022 from the SPIO, O/o the FCS & CA, Darrang, stating that the informations sought by the appellant Md. Hussain vide his RTI application dated 26.10.2021 have been provided to him through whatsapp on 25.11.2021. A copy of the informations provided and the print out of the whatsapp communication showing the delivery and receipt of the informations has also been enclosed along with the written statement. The SPIO has also stated that the blue tick mark on the whatsapp against the PDF file transmitted by the SPIO's office indicates that the appellant had already seen or received the information.
- 3. Since the appellant has in his 2nd Appeal claimed that he has not been furnished any information, the SPIO, FCS & CA, Darrang, is directed to send by registered post a set of the informations earlier sent by whatsapp to the appellant, free of cost, within 1 (one) week from the date of receipt of this order.
- 4. With the above order, this 2nd Appeal is hereby disposed of.
