1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO, District Commandant, Home Guards, Kamrup, Panikhati, Assam 781026 on 10.8.2022 seeking following information:
  - (i) Please furnish digitally in pendrive uploaded list of home guards (name) have deployed in Indian Oil Corporation Ltd. form May 2019 to till date.
  - (ii) Please furnish digitally in Pendrive uploaded list of home guards (name) deployed in IOCL without break after six months from May 2019 to till date.
2. The Asstt. PIO & District Commandant, Home Guards, Kamrup, Panikhati, Guwahati forwarded the RTI petition to the PIO & Senior Staff Officer, HG(G), O/o the Director General of Home Guards, Assam, Guwahati on 31.8.2022.
3. Reportedly on not getting any information, the petitioner filed a complaint petition u/s 18(1) before the Commission on 19.9.2022 and accordingly, the matter was taken up for hearing.
4. The petitioner Sri Joydeb Das is present.
5. The Public Authority to be represented by SPIO, Directorate General of Civil Defence & Commandant General of Home Guard, Guwahati and District Commandant of Home Guards, Panikhati, Guwahati are absent.
6. However, the Asstt. PIO, & District Commandant, Home Guards, Kamrup has submitted a written statement dated 29.10.2022 wherein it is mentioned that due to schedule meeting at the Directorate he is not able to attend the hearing at the Commission physically.
7. The petitioner said that he had certain issue on non receipt of the complete information and issue of exemption. The petitioner prayed before the Commission to fix another date and raise those issue to get clarification by the Commandant to get the information.
