1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO, Directorate of Swachh Bharat Mission on 13.5.2022 seeking following information:
  - (i) Please furnish in details of the district wise and year wise targeted achieved (constructed) against actual target for Individual House Hold Latrine (IHHL) by Mission Director, Swachh Bharat Mission, Gramin till date, with fund involved and released, along with copy of guidelines for completion period and copy of extension letter.
2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> appeal before the Mission Director, Swachh Bharat Mission, Dispur, Guwahati 781005 on 30.6.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 19.9.2022.  
Accordingly, the matter was taken up for hearing.
3. The petitioner Sri Joydeb Das is present.
4. The Public Authority is represented by Miss Monalisa Das, SPIO & AEE (PHE), Swachh Bharat Mission, Guwahati.
5. The SPIO clarified that the information is already given to which the petitioner wanted to know whether the expenditure was in lakhs or in crores, this was clarified by the SPIO that it was in crores.
6. The Commission observes that if this was the issue, the petitioner would have got it clarified instead of submitting 2<sup>nd</sup> appeal before the Commission.
7. The case is disposed off.
