O R D E R

- 1. The petitioner Joydeb Das has filed one RTI petition before the PIO, Additional Director Welfare of Plain Tribes and Backward Classes, Kokrajhar, Assam on 28.6.2022 seeking following information:
 - (1) Please furnish copy of procedure followed regarding fixation of price of various items which was procured through tender during the period 2016-17 to 2021-22.
 - (2) Please furnish whether any market verification was done regarding reasonableness of price (procured items) which was declared by the bidder in bid prior contract award/supply order of above such period, if yes, please furnish a copy of the same, if not verified the market price, please furnish the reason thereof.
- Reportedly on not getting any information, the petitioner filed 1st appeal before the First Appellate Authority, Additional Director Welfare of Plain Tribes and Backward Classes, Kokrajhar, Assam on 11.8.2022 and then he filed 2nd appeal before the Commission on 19.9.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Shri Joydeb Das is present.
- 4. The Public Authority to be represented by SPIO, Additional Director Welfare of Plain Tribes and Backward Classes, Kokrajhar, Assam is absent.
- 5. However, the Additional Director cum CHD, WPT & BC Deptt., B.T.C. Kokrajhar has submitted a written statement dated 31.10.2022 wherein it is mentioned that the sought for information is given.
- 6. The petitioner stated that reply relating to point no 2 of the RTI petition regarding market verification is not given.
- 7. The Commission directs the SPIO to furnish the remaining information within 10 days.
- 8. The case is disposed off.
