O R D E R 04/11/2022

- 1. The petitioner Smti Bandana Medhi has filed one RTI petition before the PIO, O/o the Deputy Commissioner, Nalbari on 14.2.2022 seeking following information:
 - (1) Present status of my EWS application no. 42/21 issued on28.6.2021.
 - (2) Copy of application along with the documents I have annexed, Please furnish the copies.
 - (3) Why the EWS certificate is not issued to me, Please mention the reasons if any.
 - (4) What documents were sought for getting the EWS, please inform me.
 - (5) How many applicants got EWS certificate form 1.1.2021 to 30.11.2021. Please furnish serial no. along with application and documents for all.
- 2. The Circle Officer of Barkhetri Revenue Circle, Narayanpur, Mukalmua sent a letter to the petitioner on 28.3.2022 furnishing the sought for information.
- 3. On not being satisfied with the information received, the petitioner filed 1st appeal before the First Appellate Authority, O/o the Deputy Commissioner, Nalbari on 4.4.2022.
- 4. The Circle Officer & SPIO, Barkhetri Revenue Circle, Narayanpur, Mukalmua passed an order on the First Appeal petition of the petitioner on 15.6.2022.
- 5. On not being satisfied with the 1st appeal order, the petitioner filed 2nd appeal before the Commission on 18.7.2022 and accordingly the matter was taken up for hearing.
- 6. The petitioner Smti Bandana Medhi is absent. However she is represented by her Advocate Taijuddin Ahmed.
- 7. The Public Authority is represented by Sri Uday Sankar Dutta, ACS, SPIO, Barkhetri Circle Office, Mukalmua, Nalbari.
- 8. The SPIO has submitted a written statement dated 3.11.2022 wherein it is mentioned that the sought for information has already been furnished to the petitioner on 28.3.2022.
- 9. Since the petitioner is absent, the Commission has decided to hear the matter again.
- 10. Fix another date of hearing.
