O R D E R 25/11/2022

- 1. In continuation of earlier order dated 4.11.2022, the matter was taken up for hearing.
- 2. The petitioner Sri Dulal Debnath is present.
- 3. The Public Authority is represented by Smti Kakoli B Boruah, Additional DCP(West), Guwahati.
- 4. The Deemed PIO cum Deputy Commissioner of Police, West Guwahati Police District, Jalukbari, Guwahati has submitted a written statement dated 25.11.2022 which is taken into records.
- 5. At the hearing when the Commission asked is there any rule that police will give this character certificate, the petitioner replied that there is no such rule. But as he remembers the Police Station was issuing these certificates long ago.
- 6. The Deemed PIO stated that original application is not received at the office. But the petitioner showed a postal receipt of letter dated 25.5.2022 which was received at the Office of Deputy Commissioner of Police, West Guwahati Police District, Assam on 1.6.2022. But the SPIO stated there is no record of receiving this letter at the office.
- 7. The Commission observes that this explanation is totally unacceptable as the letter is delivered at the office and after that it is not traceable.
- 8. After hearing the statement of both the parties and examining the documents, the Commission orders that since the original petition is enclosed, <u>the SPIO is</u> <u>directed to take up the matter with the addressee and dispose the petition as per</u> <u>the rule with mention of any case at the local Police Station.</u>
- 9. The case is disposed off. Authenticated copies to be given to all concerned.
