- 1. The petitioner Sri Joydeb Das has filed one RTI petition before the PIO, Assam Fisheries Development Corporation Ltd., Chachal, Guwahati on 2.8.2022 seeking some information (copy enclosed).
- Reportedly on not getting any information, the petitioner filed 1st appeal before the First Appellate Authority, O/o the Assam Fisheries Development Corporation Ltd. on 6.9.2022 and then he filed 2nd appeal before the Commission on 19.10.2022.

Accordingly, the matter was taken up for hearing.

- 3. The petitioner Sri Joydeb Das is present.
- 4. The Public Authority is represented by Shri Himangshu Bora, PIO & Project Manager, AFDC Ltd.
- 5. The SPIO has submitted a written statement dated 10.11.2022 which is taken into records. The SPIO stated that he has furnished the sought for information to the petitioner by post and the petitioner stated that he has not yet received the information and the petitioner is not satisfied to the reply given in respect of 1(d) and 1(e) of the RTI petition i.e., inspection of the documents as he wants the statements which will be couple of pages.
- 6. To this, the SPIO said that he has no problem in furnishing the statement as sought by the petitioner.
- 7. Though the PIO & First Appellate Authority violated the provision of RTI Act, 2005 in not furnishing the information within 30 days, the Commission on request of PIO did not take any cognizance. However, the Commission impresses upon the PIO that on future penalty provision will be resorted to.
- 8. In light of the above, <u>the Commission directs the PIO to furnish the statement to</u> <u>the petitioner as sought by the petitioner</u>.
- 9. The case is disposed off. Authenticated copies to be given to all concerned.
