2. Reportedly on not getting any information, the petitioner filed 1<sup>st</sup> Appeal before the First Appellate Authority, Assam State Film (Finance & Development) Corporation on 27.8.2022 and then he filed 2<sup>nd</sup> appeal before the Commission on 15.10.2022.  
Accordingly, the matter was taken up for hearing.
