1. In continuation of earlier order dated 1.11.2022, the matter was taken up for hearing.
2. The petitioner Sri Joydeb Das is present.
3. The Public Authority is represented by Sri Subash Chandra Das, Sr. SO and he is accompanied by Sri Basanta Sarma, District Commandant Home Guards, Kamrup.
4. At the hearing, the petitioner says that the Home Guard Volunteers are not force and not exempted.
5. In addition to that, the petitioner mentions the provision u/s 8(1)(j) of the RTI Act, 2005 which *quotes* (j) information which relates to personal information the disclosure of which has not relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the Central Public Information Officer or the State Public Information Officer or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information: Provided that the information, which cannot be denied to the Parliament or a State Legislature shall not be denied to any person. *Unquote.*
6. The SPIO also could not satisfactorily show any exemption letter relating to Home Guards Volunteers.
7. **Fix another date of hearing.**
